

THE SUMMER SHOW JUROR

Miranda Lash is Curator of Modern and Contemporary Art at the New Orleans Museum of Art, where she manages the twentieth and twenty-first century permanent collection and the Sydney and Walda Besthoff Sculpture Garden. She is a recipient of an Andy Warhol Curatorial Research Grant for her research on conceptual artist Mel Chin. A native of Los Angeles, she received her bachelor's degree in the history of art and architecture with honors from Harvard University. As an undergraduate, she was honored as a Fellow at the David Rockefeller Center for Latin American Studies. She completed her master's degree in art history at Williams College, where she was named a Clark Fellow for work on her Master's thesis on Brazilian artist, Adriana Varejão. Before coming to New Orleans, Lash was a curatorial assistant at The Menil Collection in Houston, Texas. She has lectured and published essays on the Latin American artists; however, since arriving New Orleans, her interests have expanded to include artists from or living in the American South. Currently, she is writing two books on the Sydney and Walda Besthoff Sculpture Garden.

ELIGIBILITY:

Open to all artists in the United States 18 years of age or older.

AWARDS:

up to \$2,500 may be awarded. \$1,000 for Best of Show. Other cash and merit awards will be presented at the discretion of this year's juror.

MEDIA:

Original visual art completed within the past two years, and not previously exhibited at STAA is accepted. Reproductions of original artwork are not admitted. Space limitations do not allow us to accommodate film, video or large installations.

IMAGES OF THE ART FOR CONSIDERATION:

All images of art to be juried should be saved in JPG format, 72 dpi, no larger than 10" on longest side. One image for each 2D work is allowed. Two images for each 3D work. Images must be titled as your last name, followed by the image number corresponding to your entry form. Email entry: Send files to summershowentry@gmail.com. Scan & email completed entry form or type all requested information in the body of your email. 10mb maximum for each email. CD entry: Save files to a single CD-R disk, titled with your name and names of images, numbered to match entry form. Mail with entry fee to STAA at address below. Discs will not be returned.

ENTRY FEE:

\$30.00 for one to a maximum of three entries.

NOTIFICATION:

Results of the selection process will be mailed to applicants on or about Friday, June 1, 2012.

INSURANCE:

Artists are encouraged to provide insurance on their work. STAA is not providing insurance at this time.

SHIPPING:

All accepted work must be shipped to STAA in reusable crates with shipping PRE-PAID for return.
